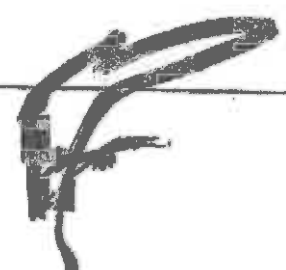
Under the regulations made under the Localism Act 2011 Members must register their "disclosable pecuniary interests".
